In exercise of powers conferred by the sub section (i) of Section 14 of the Bihar Technical Service Commission Act, 2014 (Bihar Act-13/2014) the State Government of Bihar makes the following Rules to execute the provisions of the said Act:-

The Bihar Technical Service Commission Selection Procedure Rules, 2018

1. **Short title, extent and commencement-** (1):- These Rules may be called "The Bihar Technical Service Commission Selection Procedure Rules, 2018"
 - (2) It shall extend to the whole of the State of Bihar.
 - (3) It shall come into force at once.
2. **Definition :-** In these Rules, unless there is anything repugnant in the subject or context :-
 - (i) "Department" means the General Administration Department, Government of Bihar.
 - (ii) "Concerned administrative department" means the department which sends the requisition and the department which makes the appointment;
 - (iii) "Commission" means Bihar Technical Service Commission;
 - (iv) "Schedule" means the schedule attached with the Bihar Technical Service Commission Act, 2014.
 - (v) "Online Application" means online application received through computer against the post advertised by Commission.
3. (1) The Commission will publish Advertisement for the posts mentioned in the schedule every year.
 - (2) The Commission will invite online application for posts mentioned in the schedule of the said Act, 2014.
 - (3) The Commission may invite a single application consolidated online for the posts which require similar academic qualification.
4. The following application fee may be charged from the applicant for online application :-

Sl No	The category of the candidates	Fixed applicatio fee
(i)	General category/Backward category	Rs. 200/-
(ii)	Schedule Caste/Schedule Tribes and Extremely Backward category, who are permanent resident of the State of Bihar	Rs. 50/-
(iii)	Reserved and unreserved category of women candidates who are permanent resident of the State of Bihar.	Rs. 50/-

(iv)	The candidates from other States belonging to any category either women or man.	Rs. 200/-

However, the State Government may change the above mentioned application fee from time to time.

5. The concerned administrative departments may prescribe special qualifications for certain posts mentioned in the Schedule. In such cases, candidate with prescribed special qualifications shall be considered as qualified candidates for such posts.

6. The selection of candidate shall be made on the basis of marks obtained in minimum academic qualification as prescribed in the concerned Service Cadre Rules and marks prescribed for work experience (if provided in the concerned Service Cadre Rules) against the requisitioned vacancies. In case of grade instead of marks in certificate/mark sheet of educational qualifications, grade shall be converted into marks as per formula prescribed in concerned Rules/by Concerned Departments.

7. For certain posts under provisions of concerned Cadre Rules, interview may also be taken of the candidates included in merit-list prepared as per rule-6 above.

8. (1) For those posts in whose concerned Cadre Rules there is provision for selection to be made on the basis of marks obtained and marks allotted for work experience, in such case, three times of the vacancy advertised, shall be called for document verification and on that basis merit list shall be prepared for selection.

Provided that, in case the number of candidates is less than the number of total vacancy/three times of total number, all candidates will be invited for certificate verification and on that basis merit list shall be prepared for selection.

(2) For such posts, in whose concerned Cadre Rules, there is provision for selection to be made on the basis of marks obtained, marks allotted for work experience and interview, in such cases five times candidates shall be invited for interview against the advertised vacancies and on the basis of the aggregate marks of interview, marks in academic qualification and marks of the experience of work the merit list shall be prepared and there after three times more candidates against the vacancies shall be invited for verification of certificates.

Provided that, in case the number of candidates is less than the number of total vacancy/ five times of total number, all candidates will be invited for interview.

(3) As per the prescribed provision of post and cadre rules, the commission shall take practical test/interview, verification of certificates and examination of health of the candidates and on the above said basis, the final merit list shall be prepared.

9. Recommendations of the Commission shall be sent to the concerned department after preparation of merit list. After verification of certificates, the concerned department shall also verify the antecedents of the candidate.

10. While submitting a single consolidated application for more than one department, it will be expected from the candidate to give their option based upon priority, which cannot be changed by the candidate later on. On the basis of marks obtained and verification of certificates, the commission shall send recommendation of selected candidates keeping in view the merit and option given by the candidate.

11. On the basis of merit list prepared on the basis of marks and option given by the candidate, the Commission will send department wise recommendation on its own discretion.

12. While sending requisition and preparing merit list, the rules/orders related to reservation/roster issued by the State Government from time to time shall be followed.
13. All the successful or un-successful candidate shall be entitled to know marks obtained by them from the list of marks obtained/merit list prepared by the Commission.
14. The provision related to selection process in concerned Service/Cadre Rules of the Posts mentioned in annexure shall deemed to be amended up to this extent.
15. Bihar Technical Service Commission shall be competent to fix Standard and procedure of selection, subject to the provisions of the Bihar Technical Service Commission Act, 2014, The Bihar Technical Service Commission Rules, 2015 and these Rules.
