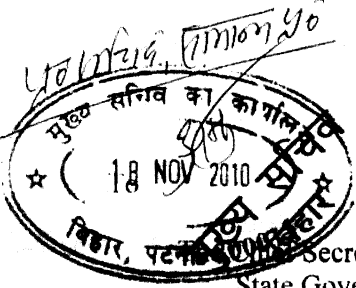

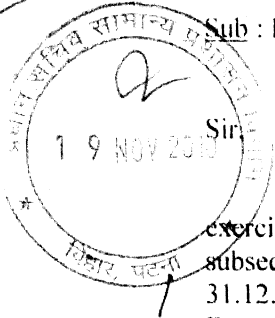


Sub : Re- exercise of option for fixation of pay in the revised pay structure-Reg.


Subject : Implementation of IAS(Pay) Second Amendment Rules, 2008 and similar rules for IPS/IFS - exercise of option - regarding

Sir,

In pursuance of the OM NO. 7/14/2010-EIII(A) dated 5th July, 2010 issued by Ministry of Finance, Department of Expenditure regarding exercise of option to switch over to the revised pay structure from a date later than 1/1/2006, I am directed to convey the approval of the Central Government to make the provisions of the said O.M. applicable to the Members of All India Services in their respective State cadres.
