VACANCY CIRCULAR

Subject: Filling up the post of Chairman, Kolkata Port Trust- Calling for Applications- -reg.

The Ministry of Shipping invites applications from the All India Service/Central Civil Services Group 'A' officer for the post of Chairman in Kolkata Port Trust in the pay scale of Rs.80,000-1,25,000/- (Industrial DA pattern) on deputation basis. Apart from the salary, the post also carries the perquisites such as dedicated accommodation, transport, medical attendance, LTC etc. The Port Trust is an autonomous body governed under the Major Port Trusts Act, 1963. Appointment to the post is made by the Central Govt. under section 3 (1) (a) of the Major Port Trusts Act, **.19**63.

The Chairman of the Port is the Chairman of the Port Trust Board. Hears the Chief Executive of the Organisation and is responsible for all aspects of Port functioning. He is required to exercise administrative and financial powers and also to supervise the functioning of various departments with the ports. The job requirements, therefore, are the following: -

General Managerial ability; (a)

Experience and talent in man-management in highly unionized (b) environment.

Experience and ability in Financial Management. (c)

- Ability to formulate and implement development plans and also to (d) prepare broad perspective plan for development of a port;
- Ability to co-ordinate with various agencies such as State (e) Governments, the Law and Order authorities, different agencies of Central Government such as customs, Railway, Ministry of Labour
- ability personnel management and Experience and in (f) understanding of establishment matters.

3. Eligibility criteria:

(i) The officers belonging to All India Services/Central Civil Services Group 'A' officers who have put in not less than 16 years of service in Group 'A' are eligible to be considered for the post. Preference may be given to those having experience of working in Port and Shipping sectors. The terms and conditions of appointment of the officers selected shall be as per the rules and instructions of Central Government.

- The post is not a part of the Central Staffing Scheme. The appointment will be made on deputation basis for a period of 5 years or as may be decided by the Competent Authority.
- The officers who satisfied the above criteria must have at least four (iii) years service before retirement.
- The Cadre Controlling Authority/the State Government is requested to give wide publicity to the vacancy and forward names of suitable and willing officers for consideration for the post. The ACRs (only attested photocopies) of the officer for the last five years (2010-11 to 2014-15) along with the bio-data in the enclosed format, and clearance from administrative/vigilance angles and Integrity Certificate may also be sent. The vigilance clearance of the officer may be sent in the prescribed proforma attached with the application form.
