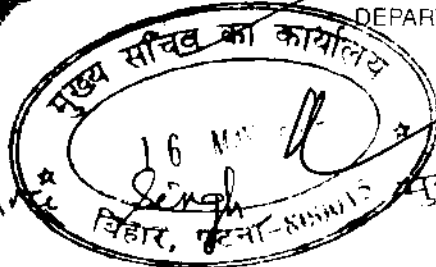

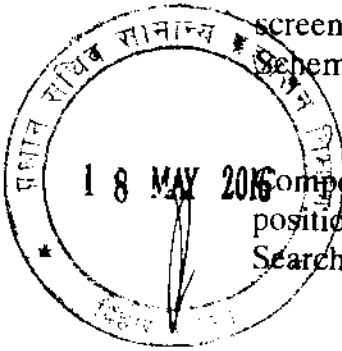

VACANCY ANNOUNCEMENT

APPOINTMENT OF ONE MEMBER (ANIMAL SCIENCES), AGRICULTURAL SCIENTISTS' RECRUITMENT BOARD (ASRB)

The ASRB is an independent recruiting agency setup with the approval of the Cabinet on the lines of UPSC.

2. It is responsible for recruitment of posts in the Agricultural Research Service, Research Management Positions and to such other posts and services as may be specified by the President of the Indian Council of Agricultural Research (ICAR). It also screens Scientists of ICAR for promotion under the Career Advancement Scheme.
3. A Search-cum-Selection Committee has been appointed by the Competent Authority for preparing a panel of names for filling up a position of Member (Animal Sciences) in the pay scale of ₹ 75,500-80,000/-. Accordingly, the ICAR is in the process of preparation of a list of names for the use of the Search-cum-Selection Committee. The Committee would consider this list and make recommendations about suitable candidates for considering their appointment to the Union Agriculture & Farmers' Welfare Minister, who is also the President of the Indian Council of Agricultural Research Society.
4. An applicant for this position of Member (Animal Sciences) should be an Eminent Scientist holding the position of Professor or its equivalent in the scale of PB-4 of ₹ 37400-67000 + RGP ₹ 10000/- and above with area of specialization in Animal/Veterinary/Fishery Sciences.
5. As per existing provisions, a Member shall hold office for a term of 6 years from the date he enters upon the office or until he attains the age of 65 years whichever is earlier. The candidates should ideally have the following attributes:-
 - (i) Record of successful administration and management of science in the field of Animal/Veterinary/Fishery Sciences.
 - (ii) Ability to communicate and inspire confidence among scientists and administrators.
 - (iii) Impeccable record of integrity with ability to take a firm stand on principles.
 - (iv) Capability to look at problems particularly in the field of recruitment with broader scientific perspective and vision.
 - (v) Modern and forward looking approach and outlook towards Agricultural Research in the global environment as also in the context of Government's policy.
6. The tenure of appointment and other terms and conditions shall be governed by the Rules & Bye-laws of the ICAR Society as amended from time to time.
7. Besides direct applications, the Chairman of UGC/UPSC/Veterinary Council of India; Secretaries of DBT/DST; Director General, CSIR; Vice Chancellors of all the SAUs/CAUs, Chief Secretaries of States/UTs may also recommend / nominate suitable candidates with their CV particulars.
8.
