(iii) Diploma in Computer Applications from a recognized University/ Institution.

Handwritten notes at the bottom: "1489/08-04-16", "4/4", "17/4/16", "4/4".

Note: The maximum age limit for appointment by deputation shall not be exceeding 56 years as on the closing date of receipt of applications.

3. The period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or other organization/ department of the Central Govt. shall not ordinarily exceed three years.

4. The applications, in duplicate, in the enclosed proforma, along with the complete and up-dated C.R. dossier for the last 5 years of the officers who could be spared in the event of his/her selection, may be forwarded to the Director (Admn.), Election Commission of India, Nirvachan Sadan, Ashoka Road, New Delhi-01 on or before 09.05.2016. Application received after the last date or otherwise found incomplete will not be considered.

5. Pay of the Officer selected on deputation will be regulated under the provisions contained in the Deptt. of Personnel and Training O.M. No.6/8/2009-Estt.(Pay-II) dated 17.06.2010 as amended from time to time.

6. In anyone is selected from a higher Scale/pay his or her pay shall be protected by the Commission.
