The officer should not be on study leave or long leave.

Desirable qualifications

Experience in the areas related to Infrastructure Development/International Trade/Public Finance in the Ministries/Departments of the Government of India or in the State Government.

Experience in Externally Aided Projects.

- Degree in Economics/Management/Public Finance/International Trade. (iii)
- This post may be circulated amongst eligible officers and names of willing and eligible officers 2. who can be spared by the State Governments/Ministries/Departments may be forwarded to this Department along with Cadre clearance, vigilance clearance, detailed Bio-data and ACR Dossier/certified ACR gradings for the last five years. It may also be ensured that "Cooling Off", after a previous stint on deputation, if any, is complete and the officer is eligible for Central Deputation. In case the officer is currently under central deputation, the nomination may be forwarded with the approval of the Minister in charge concerned and along with cadre clearance.
