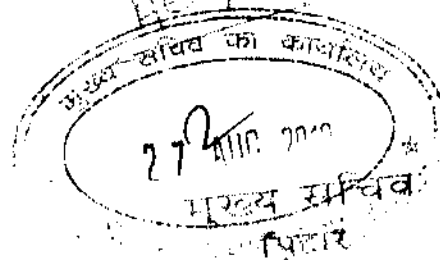

Kindly refer to my D.O. letter of even number dated 25/7/2019 regarding ongoing online updation of Executive Record Sheet by individual IAS officers and validation by the Cadre Controlling Authorities.

2. You will be happy to know that a large number of officers have already come forward and updated their profile covering personal details, posting/work experience, educational qualification and awards/publications through the online module developed on SUPREMO portal. However, these entries are required to be authenticated/validated by the respective Cadre Controlling Authorities before the changes can be reflected in the ER Sheet.

3. As on date, 1032 officers have already started updating their ER sheets and 311 officers have finalized the same. However, only 13 ER sheets have been finalized by the Cadre Controlling Authorities.

4. You would appreciate that the role of the Cadre Controlling Authorities is very crucial in ensuring timely validation of updated data so that the updated ER sheets become available online at the earliest possible.

5. I, therefore, request you to kindly review the progress and direct the concerned officers to ensure timely authentication/validation of the ER Sheets.
