

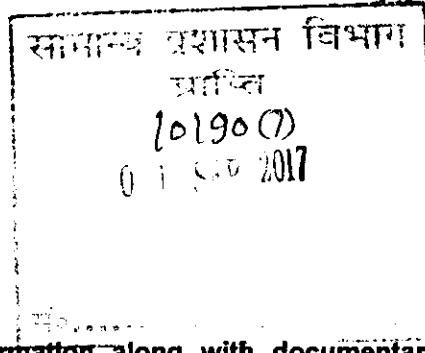

It is stated that it is frequently seen that some pension cases are being received from General Administration Department and Home (Police) Department, Govt. of Bihar in respect of AIS Officers to this office without five necessary information such as PAN No., Aadhar No. etc sought by the above said letter.

It is, further, stated that pension cases are being received without documentary evidences in support of PAN No., Aadhar No. and Bank Account No. from Hon'ble High Court in respect of Hon'ble Judges, General Administration Department in respect of IAS Officers, Home (Police) Department in respect of IPS Officers and Environment & Forest Department in respect of IFS Officers.

All concerned departments are hereby requested to send pension cases (to be sent in future) for authorization of pensionary benefits along with five necessary information with self attested / attested copy of PAN Card, Aadhar Card and First Page of Pass Book. Non submission of requisite documents / information with pension paper may lead to non processing of the pension case at our level, which may ultimate result into return of the case to the department concerned.
