Subject: Amendment to AIS (PAR) Rules, 2007- reg.

I am directed to refer to the subject noted above and to say that this Department, vide notification number G.S.R. No. 596(E) dated 16.6.2017, has amended the AIS(PAR) Rules, 2007 (copy enclosed). The amended rules have come into force with effect from 16.06.2017. The said amendments inter alia, provide:-

- (i) mandatory filing of PAR electronically, in order to avoid delays and bring more transparency, with provision for exemption in certain cases.
- (ii) to further clarify the provisions relating to writing of PAR on relinquishment of charge in order to distinguish between cases of superannuation and demitting office.
- (iii) to seek comments of reporting/ reviewing authority even after relinquishing charge/ demitting office on the representation of the officer reported upon.
- (iv) to introduce concept of Competent Authority to decide the representation of the officer reported upon and to define the procedure to be followed.
- (v) procedure to be followed on the representation of the officer reported upon by Referral Board in the cases where the Competent Authority has not seen the work of the officer.
- (vi) PARs not recorded as per the provisions of AIS(PAR)Rules, 2007 to be treated as non est.

2. Since, AIS(PAR) Amendment Rules, 2017 have come into force with effect from 16.6.2017, it is hereby clarified that all the provisions of the amended rules (except those related to consideration of representation of the officer reported upon) shall be applicable for those PARs where the officer to be reported upon has submitted his or her assessment on or after 16.06.2017.

3. Further, the amended AIS (PAR) rules provides for a "competent authority" to consider the representation of the officer reported upon against PAR as explained in newly substituted sub-rules 7 to 7(C). Accordingly, representation against PARs written even prior to 16.6.2017 under AIS(PAR) Rules, 2007, will now be considered by the competent authority as provided in the amended rules, wherever applicable.

4. The aforesaid amended PAR Rules may please be brought to the notice of all the concerned for strict compliance.
