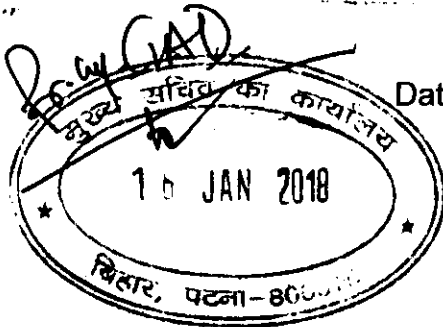

Subject: Regarding inter-se seniority of IAS officers of Bihar Cadre of 1989 batch-reg.

Sir,  
I am directed to refer to your letter No. 1/C.-1017/2009-SA.PRA.-14216 dated 09/11/2017 on the subject noted above and to say that inter-se-seniority of a batch of IAS officers is received from LBSNAA and is based on the marks obtained by the IAS officers in UPSC examination and mandatory trainings during probation period. This All India inter-se-seniority list is final and not subject to changes on events like cadre transfers.

2. State wise gradation list is maintained by respective State Governments and rule 6(3) of IAS (Regulation of Seniority) Rules, 1987 is applicable to it. The rule provides that if an officer is transferred from one cadre to another at his request he shall be assigned a position in the **gradation list of the cadre** to which he is transferred below all the officers of his category borne on that cadre who have the same year of allotment. However, his seniority in the list prepared under Rule 10 of the Indian Administrative Service (Probation) Rules, 1954 i.e. all India Inter-se seniority shall remain unaffected for the purposes of the said list.

3. In the specific case of Shri Khandelwal, necessary steps as per Rule 6 may accordingly be taken by the State Government.

4. As per disclaimer in Civil List 2017, the Civil List does not convey sanction or authority in any matter of seniority (including inter-se seniority within cadre), pay and allowances. Therefore, data available in Civil List is correct and requires no changes.


