



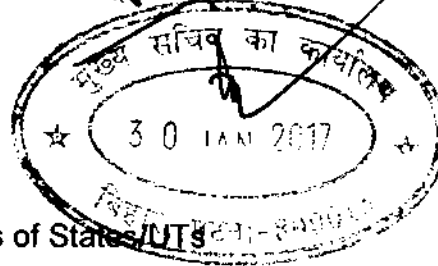

Sub: Phase III of Mid-Career Training Programme for IAS Officers in 2017

Madam/ Sir,

I am writing in connection with the nomination of eligible officers to the four-week Phase III of the Mid-Career Training Programme for IAS Officers to be held at the Academy in Mussoorie from **April 10 to May 05, 2017**. The training programme is mandatory in nature and can be ordinarily undergone by officers between **7 to 9 years** of their service. In the last round, IAS officers belonging predominantly to 2006 to 2008 batches have undergone their Phase-III training.

2. The main objective of the Phase-III training is to build 'next level competency'. These officers would be holding various responsible positions in the field, for the next few years, and would be dealing with issues pertaining to governance, service delivery, formulation and implementation of projects and government schemes, etc. Therefore, the Course aims to expose them to best practices in governance and service delivery, based on exchange of experiences and case studies, and to equip them with the tools and techniques necessary to ensure effective implementation of projects and development schemes besides negotiation and leadership skills.

3. During the cited training programme, it has been decided to train IAS officers, as indicated below:

- (i) 1st Opportunity to IAS officers of 2009 batch;
- (ii) 2nd opportunity to officers of 2008 batch, and
- (iii) 3rd and last opportunity to the residual officers of the 2007 batch to complete Phase III training

Decision on participation of residual officers of 2003 to 2006 batches (who have availed of 3 opportunities or more already) will be taken based on the merits of each case by the DoPT.

4. State/ UT Governments as well as Departments of Government of India are requested to ensure participation of all eligible officers. For postponement of participation of officers *in rare and extraordinary circumstances*, necessary approval of the Training Division, DoPT must be obtained keeping in view the guidelines issued vide No. M-15011/03/2009-MCT dated 19.3.2010. Any approval for postponement of participation does not entitle the officer to obtain the respective promotion/ grade/ increment in relaxation of the Rules. Further, nodal Governments are requested not to nominate the names of the eligible officers for deployment for any short-term training course or any alternate duty during the period of the Phase III training without DoPT's prior approval. However, officers superannuating before **May 31, 2020** may not be nominated for the Phase III Programme.

5. In order to facilitate "Online Registration" of eligible officers, I would request you to advise the eligible officers to register forthwith at the link Mid-Career Training Programme under Training Programmes on the home page of the website of the Academy (<http://www.lbsnaa.gov.in>) by **February 28, 2017**. The respective State Governments/ Nodal Ministries in GOI may also communicate their consent to the participation of the concerned officers in the training programme, latest by **March 15, 2017**. For any further clarifications, prospective participants may write to the Academy at trg4.lbsnaa@nic.in.

6. I request you to kindly ensure timely enrolment and Government clearance of eligible officers for their participation in the Phase III training. Final confirmation of participation shall be communicated by the Academy based upon enrolment and receipt of clearance from the concerned State or Union Government. The officers may be directed to report at LBSNAA, Mussoorie on **April 9, 2017 (Sunday)** for attending the training programme.
